Ceres Northgate Terminal is located in southeast Saskatchewan, about 80 miles (125 kilometers) northwest of Minot, North Dakota and 30 miles (55 kilometers) east of Estevan, the center of Saskatchewan's energy.

Strategically located on Saskatchewan's heavy haul highway corridor and the Canada/United States Border, the terminal allows easy truck access to energy development, industrial users and the growing agricultural sectors in both the United States and Canada.

The terminal, and its associated infrastructure, represents an investment of over \$100 million and is integrated with United States and Canadian Customs Services for seamless North American trade. Adequate water, power and utilities are readily available.
